Annual Military Equipment Report

Pursuant to California Government Code §7070(d)(6), and in accordance with California Government Code §7072, the Central Marin Police Authority will submit to the Central Marin Police Authority Police Council an Annual Military Equipment Report and will make that report publicly available on its internet website. The Annual Military Equipment Report will include the following information for the immediately preceding calendar year for each type of military equipment:

1. A summary of how the military equipment was used and the purpose of its use.
2. A summary of any complaints or concerns received concerning the military equipment.
3. The results of any internal audits, any information about violations of the military equipment use policy, and any actions taken in response.
4. The total annual cost for each type of military equipment, including acquisition, personnel, training, transportation, maintenance, storage, upgrade, and other ongoing costs, and from what source funds will be provided for the military equipment in the calendar year following submission of the annual military equipment report.
5. The quantity possessed for each type of military equipment.
6. If the law enforcement agency intends to acquire additional military equipment in the next year, the quantity sought for each type of military equipment.

The Central Marin Police Authority Police Council will use the Annual Military Equipment Report as a mechanism to ensure the Central Marin Police Authority’s compliance with this Military Equipment Use Policy, and to help it determine whether to approve, revise, or revoke components of the Military Equipment Use Policy for the subsequent year.

<p>Use Summary: Case details documented in CMPA case #PA22-0329. On February 24, 2022 at approximately 2pm, CMPA Officers were dispatched to Peet's Coffee, located at 77 Casa Buena Drive in Corte Madera on the report of a suspicious package. CMPA officers arrived on scene and were contacted by three officers from the California Highway Patrol, who stated they were seated at a table outside of Peet's when an unidentified subject approached them and asked them to deliver a package to the US Secret Service in San Francisco. The subject threw the package at the CHP officers and then quickly fled the area, running away from the officers, furthering their suspicion that the device left behind may be dangerous.</p>

The incident commander made the determination to cordon off the area to keep innocent bystanders away and then notify the UC Berkley Bomb squad which is standard procedure in these instances. UC Berkley's Bomb Squad advised their response time was delayed up to 3-4 hours due to another call they were handling. The Central Marin Fire Department also responded to assist and a member of the hazardous materials teams was on scene

In the interest of not disrupting traffic and public safety for an extended period of time, the Incident Commander requested the deployment of the Avatar robot. The robot was deployed with the mechanical arm to render the package safe for hazmat to further investigate. Ultimately, the package was rendered safe and the area was opened for normal traffic. The use of the robot ensured the safety of the first responders on scene and allowed for a successful resolution to this incident with minimal impact to the residents and local businesses.
